

FIRST FALL TOUR A GREAT EXPERIENCE - The Committee conducted its first tour of the Natural Area on November 6th. Alan Baldwin of Redwood City usually brings the 6th graders of his school for a week's learning experience during the spring. To avoid the unpredictable March weather, he made it a fall activity this year. As soon as one group ended their week at the DTNA, the other group began theirs. Our concern about the lack of wildlife activity during the late fall was for nought. As usual, the DTNA provided (for those who really looked) a rich natural experience. Supplied with tally sheets for a variety of life forms and evidences of living organisms, the groups of students proved to be great detectives. Highlights of the sightings include: 6 tortoises in burrows; 1 tortoise just outside the burrow; over 15 tarantulas of various sizes; a creosote bush katydid; and 2 hatchling Mojave green rattlers.

1983 SPRING TOURS: We will be using a more directed format for our upcoming group tours this spring. In addition, the Committee is scheduling 2 open tours: Sat., April 16th and Sat., May 7th; for individuals who wish more guidance than is offered at the self-guided Interpretive Center, or who are not affiliated with a group. On both dates, we will meet at the Interpretive Center at 9 AM. Group tour reservations or other information requests should be directed to Tour Chairperson, c/o the Committee address. This should be a beautiful spring on the DTNA, especially during April and May. It's first come, first served; so make your reservations early!
